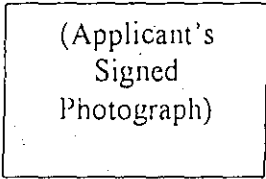

## NON-QUOTA VISAS

### a. 13(a) VISA FOR WIFE OR HUSBAND OR UNMARRIED MINOR CHILDREN OF PHILIPPINE CITIZENS

- a) Duly accomplished visa application form (FA Form No. 3);
- b) Passport valid for at least six (6) months beyond authorized period of stay in the Philippines and subject to the provisions stated in FSC 295-99 (enclosed as *Appendix G-5*);
- c) At least two (2) passport-size photographs taken during the last six (6) months, quarter profile showing earlobes;
- d) Had contracted a valid marriage with a Philippine citizen;
- e) The marriage is recognized under existing Philippine laws;
- f) For dependent children under twenty-one (21) years old and who will be joining or accompanying the applicant, sufficient proof of blood relationship with applicant is required;
- g) Has no record of any derogatory information against applicant in any local or foreign law enforcement agency;
- h) Has sufficient financial capacity to support a family and will not become a public charge;
- i) Police Clearance issued by the national police authorities in the applicant's country of origin or legal residence, authenticated by the Philippine Foreign Service Post having consular jurisdiction over the place;
- j) Medical Health Certificate issued by an authorized physician including standard-size chest X-ray;
- k) Must not be an excludable alien; and
- l) Must not be in the DFA Blacklist.
